Additional Clarifications

1. Any organization that has **not** conducted not conducted any trainings in PMKVY in 2016-18 will be considered only under Category 1, Category 2, and Category 3 subject to the eligibility of the individual category of proposals irrespective of accreditation under SMART

2. Applicants can apply for any job role from list 1, list 2, list 3 and list 4 as per below link:

However, while allocating target preference will be given to job role list 1 and list 2.

Irrespective of accreditation under SMART, an applicant can apply under Category-1, Category-2 and Category-3 basis eligibility defined in RFP. Only Job roles from list 1, list 2, list 3, and list 4 will be applicable for the purpose of this RFP. Only the selected centers will need to go through center accreditation.

In case center is proposing a job role different from the one it is currently accredited in, and if selected, the TP will have to change the job roles for the center in accordance with the proposal and get the same accredited and affiliated on SMART before starting trainings.

3. For applying to PMKVY RFP, category will be decided at Training Provider/ Organization level as per Section 4.1 of the RFP

4. In RFP, partnership with NSDC means any organization who have signed MOU/ Agreement for becoming funded and non-funded partner which means debt/ equity partner. Accreditation from SMART or any trainings conducted under PMKVY will not be considered as a partnership with NSDC.

5. Proprietorships and Partnerships organizations will be acceptable in Category-4, in case if Training Centres that have conducted training in PMKVY central component and has provided more than 40% placement and other conditions as per Section 4.1

6. There will not be any guarantee for getting targets allocation under RFP-PMKVY scheme, on the basis of fee paid or otherwise.
7. The maximum score any applicant can get as per the evaluation matrix will be **100**. In case minimum mark will be decided, the same will published at the time of proposal evaluation. There is no minimum mark as of now to get targets.
8. The applicant may be involved in community engagement activities related to Health, Education, Livelihood, and others. Please refer to the list of documents for the same that need to be provided for establishing such experience.
9. Applicants must ensure that all necessary/complete documents/information must be provided while applying in the RFP Portal. Scoring and evaluation of the applicants and the proposals will be done based on correctness and completeness of the information and documents as provided by the applicants.
