### CORRIGENDUM NOTICE

Date- 18.03.2019

**RFP Name: RFP for Selection of Agency by Bihar Skill Development Mission (BSDM) for conducting "Sectoral Skill Gap Study and Youth Aspiration Mapping Study" in all 38 Districts of Bihar vide Ref. No. BSDM/07/2018-2019 dated 28.02 2019 published in papers vide PR No. - 18429 (LRD) 2018-19.**

In view of pre-bid meeting dated 15.03.2019, certain modifications/amendments in some of the provisions of above RFP has been made as below:

1. **Under point 2-Team Qualification & Experience** of "point B- Technical Evaluation", under clause 6 "Evaluation of Bids" of section "Instructions to the Bidders" (page 16 of 25), of the Term "Team experience" the word Data collection team stands deleted and the term "Team experience" should be read as under:

\* Team Experience: Relevant experience as well as relevant skills & competencies; Professional expertise, knowledge and experience with similar projects".

2. The whole of 2<sup>nd</sup> para under **Duration of Assignment of "clause V, Key Deliverables and Time line" under Scope of work is amended and should be read as below (page 11 of 25):**

"BSDM may impose a penalty to the maximum of 10% on account of failure in submitting acceptable deliverables and non-adherence of timelines/ deviation in prescribed team structure (refer point D- Manpower deployment under Point 3- Other terms of reference of Instruction to the Bidders) apart from forfeiture of Performance Guarantee, cancellation of agreement and non-payment. The decision of CEO, BSDM will be final and conclusive in this regard".

3. The first para of marking under "point 3- Organizational Capacity and project Experience of "point B- Technical Evaluation", under clause 6 "Evaluation of Bids" of section "Instructions to the Bidders" (page 17 of 25) is being wholly amended and should be read as under:

- **12 marks** for each relevant research experience in the field of conducting Nation-wide (National Scenario) Skill Gap Studies/ Skill Demand Supply Survey/ Job Market Studies for National Agencies.
- **10 marks** for each relevant research experience in the field of conducting Skill Gap Studies/ Skill Demand Supply Survey in State/Union Territories of India.
- **7 marks** for each relevant research experience in the field of conducting Skill Gap Studies/ Skill Demand Supply Survey at the sub national level.
- **5 marks** for each relevant research experience in the field of conducting Skill Gap Studies/ Skill Demand Supply Survey at the sub state level.

Subject to cumulatively maximum of 55 marks.


**Also the Note of "EVALUATION CRITERIA OF TECHNICAL PROPOSAL (ST)" (page 17 of 25) is being wholly amended and should be read as under:**

#### Note:

- Only the International/ National/ sub national/ State/ sub state Level Skill Gap Studies/ Skill Demand Supply Survey/ Job Market Studies will be considered.
- For the purposes of evaluation, a study/survey would be considered as sub national if it covers more than more than two states/ UTs.
- For the purposes of evaluation, a study/survey would be considered as sub state if it covers more than five districts or more than half of the total number of districts in that state.
- Any study named other than skill gap analysis will be considered only if terms of reference/ scope of work contains amongst other skill gap studies.
- In case any prior experience documents are in language other than in English or Hindi, the bidders will also need to submit/upload a translation thereof in English Language.

The other terms and conditions of the RFP document will remain the same. Please refer the RFP document for other details.
