The main aim of MAPCET is to organize various skill developments training program for youth of scheduled caste and scheduled tribe community of the M.P age between 18-45 year to enhance their employment/self-employment opportunities.

This **REQUEST FOR PROPOSAL (RFP)** from NSDC affiliated training partners/Provider is to undertake the project of skill development training and employment for unemployed Tribal youths of Madhya Pradesh under the MUKHYAMANTRI KAUSHAL SAMVARDHAN YOJNA & MUKHYAMANTRI KAUSHALYA YOJNA at existing 47 VTC/TCPC (Vocational Training Centre/ Training cum production centre) of Tribal Welfare Department Govt. of M.P (Details enclosed Part-2).
