## EOI for submission of Project Proposals Under (DDU-GKY) , Rajasthan

RSLDC invites applications from the interested Project Implementation Agencies (PIAs) under DDUGKY scheme to allot a target of 26795 for skilling rural poor youth. These comprises 9000 for long term courses (duration more than 1152 Hrs.) and 900 for Person with Special Ability. Kudumbashree has been empaneled as the Appraisal Agency under DDU-GKY in Rajasthan. Interested PIAs having PRN allotted from MoRD, may apply online on the website <https://erp.ddugky.info> along with the non-refundable requisite fee of Rs 25,000/- for initial Screening in favour of 'ED Kudumbashree QA Rajasthan' to SB A/c No. 6820784668 (IFSC Code: IDIB000P030, Bank & Branch: Indian Bank Pattom Branch, Thiruvananthapuram). Shortlisted Agencies will be intimated to deposit Rs.1,50,000/- for Quality Appraisal. Details for filling up online application form and deposit fees is available on the website. Applicant PIA should read the guidelines and manual Standard Operating Procedures (SOPs) carefully before filling up the application form. The Guidelines and SoPs are available on the website of MoRD i.e. ddugky.gov.in.

Under DDUGKY project, agencies that can train and place candidates according to the skill gap existing in different sectors are encouraged to apply. RSLDC encourages employers/industries to apply under this project who can commit assured captive placements. It is to be noted that the agency applying for the DDUGKY project shall bear the expenses as detailed above for undertaking the project appraisal by agency on behalf of RSLDC. The Appraisal of the proposal shall be carried out with the following conditions:

1. Projects are to be proposed only for the districts mentioned in table below. For district Udaipur, Jodhpur and Churu applicant agency must specify the block name from the blocks identified as given below: -

Applicant agency must cover districts from all the category (Aspirational, Tribal Area's District, Desert and other districts) ensuring three preferences from each category as per format in **Annexure A** which must be uploaded / submitted with eligible documents at the time of Quality Appraisal. The information in annexure A is taken only for information purpose. Actual allotment across Aspiration/Tribal/Desert/Other districts may or may not be as per the preferences given in annexure A.
3. It must be noted that project proposals exclusively for aspirational district will avail relaxation in BG @6.25% of Project cost instead of 10%.
4. Projects applying under DDUGKY RSLDC have to comply the sub category targets given in the table below:


5. PIA can also opt any of the 33 districts of Rajasthan if applying for following projects under following categories:
  - i. Projects for Special category (Person with special ability/ Manual Scavengers/ Women Headed Households)
  - ii. Long term projects (above 1152 hours)
6. Preference shall be given to projects with undermentioned guarantees:
  - i. Foreign placements
  - ii. 30% of captive placement by the firm
  - iii. Projects in the field of Gems & Jewelry, Aerospace & aviation, Hydrocarbons, Food processing, Green jobs, Artificial Intelligence, Leather & Agro based sectors.
