

## Jan Shikshan Sansthan Kaushalacharya Awards 2021

### **Objective:**

The objective of the Kaushalacharya Award is to recognize outstanding contributions of the part time resource persons who put their efforts in the field, in order to achieve the objectives of the scheme and bring a change in the lives of the target group i.e. underprivileged and marginalized section of the society in the rural and urban slums including non /neo-literates, school dropouts from unskilled, and unemployed youth particularly from Women/SC/ST/OBC Minority /Divyangjan through skill training.

### **Award Categories: - Resource Persons of Jan Shikshan Sansthans:**

The resource persons of Jan Shikshan Sansthans who have worked selflessly towards the benefit of the beneficiaries of this scheme who have performed beyond their duties in order to change lives of the beneficiaries by providing them the moral and technical support during and after training through counseling and motivation. Also resource persons who have extended their support in finding sustainable livelihood opportunities for their beneficiaries and assist in mobilization of bank loans. The applicants will made self-nomination in a designated form (Annexure I) and same will be certified and forwarded by concerned JSS Director.

As the maximum numbers of Beneficiaries were enrolled in the following categories in last three years, therefore this year the categories of Kaushalacharya awards are also bifurcated in 5 categories:

5	Technical (Electrical, AC & Plumbing)

### **Minimum eligibility criteria for applicants**

1. Minimum of 3 years of engagement as resource person with a particular Jan Shikshan Sansthan
2. Minimum 120 Beneficiaries trained in last 3 financial years
3. Those who already got Kaushalacharya Award are not eligible for the award.
4. Those working in any Government Department/institutions are not eligible the award.
5. JSS can nominate only one applicant under each category.
6. This award carried a certificate.

## Parameters

1. Experience in vocational training
2. Training performance taking into account following parameters:
  - Number of persons trained with social / economic categories
3. Professional / Outstanding Achievements
  - SHG/JLG formed and activated
  - Exhibitions participated
  - Daily reporting to Program Officer through Whatsapp/Phone call
  - Any other innovation introduced in the teaching learning process
4. No. of trainees trained by him / her got wage/ self / private employment
5. Awards and Rewards received by the Trainer/Resource Persons during the last three years

**Award categories: Resource persons of Jan Shikshan Sansthan**

The resource persons of Jan Shikshan Sansthan who have worked selflessly towards the benefit of the beneficiaries of this scheme who have performed beyond their duties in order to change lives of the beneficiaries by providing them the moral and technical support during and after training through counselling and motivation. Also, resource persons who have extended their support in finding sustainable livelihood opportunities and mobilization of loans for their beneficiaries.

The category for the nomination will be **National Award for Excellence in training – Resource Persons – JSS Scheme**

The award applicants shall made self nomination in a designated form with a link to be provided at JSS Portal i.e. [www.jss.gov.in](http://www.jss.gov.in) and as Performa (Annexure I). The filled form will be certified and forwarded by concerned JSS Director.

- The application of the resource person has to be certified and forwarded by the concerned Jan Shikshan Sansthan through JSS Portal.
- The Quantitative data of the nominations will be fetched / validated through JSS Portal.
- The winners will be informed through email upon selection by competent authority
- The winners will receive the awards in the Kaushalacharya Awards function
